<p>A PERSON IS QUALIFIED TO SERVE AS A PETIT JUROR IF THAT PERSON:</p> <p>(1) is at least 18 years of age;</p> <p>(2) is a U.S. Citizen, resident of the state, county and city in which one is to serve as a juror;</p> <p>(3) is qualified under the constitution and laws to vote in the city in which one is to serve as juror;</p> <p>(4) is of sound mind and good moral character;</p> <p>(5) is able to read and write the English language;</p> <p>(6) has not served as a petit juror for six days during the preceding 6 months in a district court or 6 days during the preceding three months in the county court;</p> <p>(7) has not been convicted of a felony or theft;</p> <p>(8) is not under indictment or other legal accusation of misdemeanor or felony theft or any other felony.</p>	<p>A PERSON MAY CLAIM EXEMPTION IF THAT PERSON:</p> <p>(1) is over 75 years of age;</p> <p>(2) has legal custody of a child or children younger than 12 years of age and serving on the jury requires leaving the child or children without adequate supervision;</p> <p>(3) is a student of a public or private secondary school;</p> <p>(4) is a person enrolled and in actual attendance at an institution of higher education;</p> <p>(5) is an officer or an employee of the Senate, the House of Representatives, or any department, commission, board, office, or any agency in the legislative branch of State government;</p> <p>(6) has served as a petit juror in the City of Denton in the preceding 24 months;</p> <p>(7) is the primary caretaker of a person who is an invalid unable to care for him/herself.</p>
